

New Programs Offered in FY20 – Certified Nursing Assistant (CNA) ICAPS Program

To encourage adult education students to earn a college certificate that will allow them to start working in a career pathway, the Adult Education program offers the Integrated Career and Academic Preparation System (ICAPS) program.

The ICAPS program consists of dual enrollment in Adult Education and the CNA Career and Technical Education courses. The students' successful completion of the ICAPS program results in the completion of the high school equivalency (GED), a college credential and/or college credits, and the CNA certification. Once the program is successfully completed, students are able to work in an entry-level position in the specific career pathway. Students are encouraged to continue their education in order to earn a higher-level certificate or college degre

### Illinois Division of Rehabilitative Services FY 20

The DRS Vocational Rehabilitation (VR) program assisted 4,610 individuals with significant disabilities in obtaining competitive integrated employment in the community. While this represents a 10% decrease from FY19, it should be noted that DRS had 34 vacant rehabilitation counselor positions during the year and the COVID 19 pandemic caused a historical unemployment situation nationally. DRS continued the Community Partnership Initiative in FY2019, where 90 community agencies conducted outreach activities across the state involving more than 1,000 individuals with disabilities identified as potential VR program customers. The Community Reintegration Program helped 56 individuals with disabilities move from nursing facilities to their own home in the community. This represents a 50% decrease from FY19, however DRS continues to work with Centers for Independent Living across the state to make these important transitions a reality. The Home Services Program (HSP) provided services to 31,278 individuals with significant disabilities in FY2020, about 4% more than the figure of 29,967 individuals from the prior fiscal year. HSP customers receive assistance with activities of daily living such as dressing, bathing and cooking that enable them to remain in their own homes.

Over 41,000 individual providers work with HSP customers to ensure that they receive services in a safe and clean environment. The Secondary Transitional Experience Program (STEP) provided preemployment transition services (PTS) to over 10,000 high school students with disabilities in FY2020. STEP is a partner-ship with local school districts and cooperative which provides work-based learning experiences, job exploration counseling and workplace readiness training to students in order to enhance their opportunities for employment after leaving high school. The Bureau of Blind Services (BBS) assisted 153 individuals who are blind or visually impaired in achieving competitive integrated employment in FY2020. In addition to rehabilitation counseling, BBS also provides orientation and mobility training, as well as training from rehabilitation instructors which prepare blind individuals for employment.

### BEST, Inc. - Adult, Dislocated Workers and Youth

### Incumbent Worker Training

For Program Year 2020 a total of 139 employees were trained through the Incumbent Worker Training program. Total expenditures and obligations for the year ending June 30, 2020 were \$122,531.88. Step A

### Rapid Response

Covid provided some challenges in the Spring of 2020 with providing Rapid Response Services. Working with DCEO a virtual presentation was developed in order to provide the necessary information while also recognizing the need to social distance for the health and wellbeing of DCEO, IDES, and BEST staff. In total, PY19 saw permanent layoffs of over 990 employees. Layoffs included the full closures of: Energizer in Dixon, Compliance Coils in Chadwick, Covia (3 locations in La Salle County), Mendota Lutheran Home, Del Monte in Mendota, Vistra Energy in Hennepin, Elizabeth Nursing Home in Elizabeth. And smaller layoffs happening at US Silica in Ottawa, Mennies Machine in Mark along with the relocation of Cater Motoring to Wisconsin (employees transferred to new location). Additional CoVid 19 temporary layoffs were also experienced with no Rapid Response being necessary.

### Workshops for the Illinois Department of Human Services

Workshops were held monthly on the last Wednesday of the month, from July to November, and then in January and February. Subsequent workshops were cancelled due to COVID-19. Attendance at each workshop averaged between 5 and 10 people per month.

Topics covered included, identifying skills, networking, and resume preparation. Additional topics are covered as they arise among participants; such as interviewing, job fair etiquette, etc. Staff also discuss those employers most likely to employ people who have been out of the job market for a period of time. Invitations to the workshops are mailed out by DHS staff to clients for each month.

### **Employer** Conference

We held the Sixteenth Annual Employer Conference on October 4, 2019 at the Mendota Civic Center. Approximately seventy-six (76) people were in attendance. Presentations included: *Legalization of Recreational Marijuana* presented by Jeffery Risch, Attorney at Law, and Trauma in the Workplace by Mark Sanders.

### Education Outreach Program – Lee Ogle Whiteside Regional Office of Education

Provides youth with academic instruction toward completion of high school equivalency, career information, work-based learning, job search assistance, supportive service and training for in-demand occupations

Services are provided to youth ages 17-24 who have dropped from school and live in Lee, Ogle, and Whiteside Counties.

The program served 95 youth this year. Site locations include Sterling, Oregon and SVCC

### Step Ahead – Henry Bureau Regional Office of Education

Provides youth with academic instruction toward the attainment of a high school diploma or high school equivalency certificate and also provides work-based learning opportunities

Instruction is provided, usually one-on-one, at the local library in each youth's community. Youth are 17-24 years old, have dropped from school and live in Bureau County.

Program served 10 youth this year

### **Regional Work Study – Regional Office of Education #35**

Provides youth from Putnam and LaSalle counties with academic instruction toward the attainment of a high school diploma and also provides employment opportunities

Instruction is provided at IVCC in Oglesby, IVCC in Ottawa and at the library in Mendota. Youth are 16-21 years old and have dropped from school.

Program served 28 youth this year

### Work in The Real World

Annual career informational fair for high school students

Event is held at Sauk Valley Community College

253 students registered for the event from schools in Whiteside, Lee, Ogle, Carroll and Bureau counties

Over 40 employers and educators provided information about careers in Agriculture, Architecture, Art, Building Trades, Business, Computer Technology, Cosmetology, Criminal Justice, Digital Arts, Education, Engineering, Entrepreneurial, Health Care, Hospitality, Human Services, Manufacturing, Mechanics, Military, Music, Nursing and Logistics.

### Adult Redeploy Workshops

BEST partners with LaSalle County Probation to provide Job Search workshops for job-ready clients referred by the department. In program year 2019 BEST held workshops for 3 Adult Redeploy clients.

### **Tri-County Opportunities Council**

Established in 1965 by a group of concerned citizens in the counties of Lee, Ogle and Whiteside, Tri-County has grown to serve a total of nine counties- Bureau, Carroll, LaSalle, Lee, Marshall, Ogle, Putnam, Stark and Whiteside. Our mission is to investigate the impact of poverty throughout our nine county service area and to work, in partnership with individuals, families and communities to provide opportunities that supports movement towards stability and self-sufficiency. Our organization does this through a variety of programs. All programs are income based and require an application.

The following services are available to low income households:

### **Community Services Block Grant Program (CSBG)**

Provides comprehensive needs assessment, information and referrals and numerous case management programs to eligible customers to obtain self-sufficiency for employment, youth, education, housing, medical and emergency needs. Offers various housing programs to those facing homelessness or on the verge of becoming homeless. Annually awards education scholarships to income eligible service area residents attending an Illinois institution of higher learning. Bureau County Food Pantry- Provides food to meet meals gaps to families residing in Bureau County. COVID 19 programs are available in the areas of housing, health, food assistance and transportation needs for those who have been laid off, had a reduction of work hours or have been quarantined due to Covid 19.

### Low Income Energy Assistance (LIHEAP)

Makes a one- time payment to the utility company. Repair or replace furnaces to homeowners who are current on their mortgage and taxes. Percentage of Income Payment Plan (PIPP) is designed to help clients' pay their own bill with a manageable budget bill.

### **Illinois Home Weatherization Program**

Make homes more energy efficient, provide safe heating equipment, if needed, replace furnace and provide clients with safety equipment.

### **Foster Grandparent Program**

Provides meaningful volunteer opportunities for those in the lower income range who are 55 years old and older. This program offers supportive person-to-person services to at risk children in reading, math, spelling, are and other constructive projects.

### Head Start/Early-Head Start Program

These programs are federal programs that provides comprehensive early childhood education, health, nutrition, and parent engagement services to children from birth to 5 years of age, expectant mothers, and their families.
