I am writing to request a budget modification in the contract for the Whiteside County ROE Education Outreach Program for Program Year 2013. The request is outlined below.

Transfer \$3,000 from Lee/Ogle Instructor Salary to Advanced Academic Training

Funds from the Lee/Ogle Instructor salary are available since an instructor for this area has not yet been hired. Fifteen students from Lee and Ogle County have enrolled in the Education Outreach Program so far this year. However, these students are currently attending GED classes at the Wallace site or through Sauk Valley Community College, Kishwaukee College, Highland Community College, or Oale County Probation.

I am requesting to transfer the \$3,000 to Advanced Academic Training so we can enroll 8-10 youth in a Welding/GED program at Sauk Valley Community College in March. SVCC has decided to offer the program again this year. The program was provided last year at the cost of \$800.00 per student. Ten students from the Education Outreach Program participated last year. Program cost included tuition for Welding 106 (Fundamentals of Welding); welding equipment; and academic/GED instruction. I anticipate the cost and components of the program to be similar this year.

At this time, I am not requesting any changes to the limits of the budget. Thank you so much for your consideration of this matter.
