The Opioid Dislocated Worker Grant currently has 8 impacted participants enrolled into a Paid Work Experience throughout the 8 County Territory. We have 1 that has moved from a Paid Work Experience to an OJT with Perfectly Flawed. She had started as a Peer Support Specialist and is now the Peer Coordinator and running the Mobile Wellness Outreach Van that Perfectly Flawed was able to obtain through another Grant. We are working with 2 inquirants on completing their intake process and then will be placing them with worksites in the Whiteside County. These impacted participants were referrals from Sinnissippi Center Recovery Homes.

Kim, our Education Coordinator has been working closely with our Southern Territory Job Coach with leads on possible 2<sup>nd</sup> Chance Employers in the Bureau, LaSalle, and Putnam Counties. Over the duration of the Grant, Kim has built great relationships with our Clients and 2<sup>nd</sup> Chance Employers. Our partnership with Perfectly Flawed, has been able to provide an OJT that was mentioned above, in addition to bringing on a Mobile Outreach Specialist that helps to support the Peer Coordinator. This Mobile Outreach Van covers both Bureau and LaSalle Counties.

Both Job Coaches, Stephanie and Laurie have been doing an outstanding job with Case Management and trying to avoid any gaps in services with referrals. This of course, has not been an easy process with COVID. They continue to contact potential 2<sup>nd</sup> Chance Employers and provide great "interviews" to referrals.

Transportation Providers - NCAT, LOTS, and BPART are still being utilized and been a tremendous supportive service to our Clients.

I have been attending monthly meetings with CPASA, C5 Rural, and Project OPEN. By being a part of these Coalitions, it has provided a great network opportunity for reaching out to possible 2<sup>nd</sup> Chance Employers and potential Clients. I also attend additional workgroup meetings for both C5 Rural and Project OPEN that help to support the mission of Workforce Development, identifying Social Determinants, and the Recovery Process.

With things slowly starting to open back up, we are seeing an uptick in inquiries both from  $2^{nd}$  Chance Employers and potential candidates for the Grant.

Apprenticeship Expansion Grant Update (See report from Dianna Schuler below)

Our most recent sector event was held on March 25th at 9am with the Logistics Sector (including manufacturers with logistics divisions). Twenty-six (26) companies were invited. Remaining sector to schedule is Hospitality. Hospitality will be schedule in the coming weeks.

Since our last report we have meet with a total of 140 individuals/companies either one on one or through our group events. We've held a total of 6 events with a total of 140 participants. Since February we held the Ag/Agri Business event and on February 8<sup>th</sup> we met with Forster Products

in Lanark. The owners are planning to expand their market and thus their productivity and have expressed excitement about the possibility of an apprenticeship program to attract employees. They currently have an aging workforce and will need to do some demand planning to fulfil their talent pipeline. Follow up with Forster is ongoing. We have also met with GrainCo following the Ag/Agri Business event and are working with them to see how their current internship program can be converted to an apprenticeship program. We have had 3 meetings with Elliot Aviation. They would like to see their technicians, cabinet makers and upholsters in apprenticeship programs. They do customization of Cessna airplanes. Because they are in Rock Island County we have been working with the DOL Apprenticeship rep from Iowa along with the company. They are currently looking for possible training providers that will fit their needs and then we will regroup to finalize their programs, assuming they can find a training provider that is conveniently located for them.

In addition to the establishment of new and expansion of existing apprenticeship programs, the grant is also focused on expanding the number of registered apprentices in our region by 20. It allows us to count any first year apprentice that we may have worked with through our Title 1 funding and we can count those we served through Title 1 since July 1, 2019. Thus far we have served 16 first year apprentices through Incumbent Worker Training for a total of \$22,610 in leveraged funding. We have reported such on our report to DCEO. We currently have 3 more in our regular WIOA funding incumbent worker training program that we will not be able to count toward our 20. The company that these additional 3 apprentices work for have to re-sign their standards since they recently made a change in the provider for their welding component.

We are currently in the process of drafting our most success story for the quarter ending March 31<sup>st</sup>. Which is a requirement of the grant.

Nikelle and I will keep the board apprised of developments as they unfold.

Update on the 1E Small Business Grant (See Report from Dianna Schuler below)

Of the 19 companies benefiting from this grant, 3 decided to not receive the funding after their approval, 15 have been reimbursed for their expenses, and 1 still has documentation to submit to us. We expect the last company will be in a position to close out by the end of April. We are hoping to be able to close this grant out early. Two success stories have been submitted to BEST Board for this grant along with the expressed appreciation from Ramza Insurance in Streator and Ottawa
