# Review of Commercial Drivers License-Truck Driving Entrepreneurship Program at Sauk Valley Community College

Gerald informed members that the Oversight Committee recommended that the Commercial Drivers License-Truck Driving Entrepreneurship Program submitted by Sauk Valley Community College not be approved. Providing a rationale for this decision, Carrie explained that it appears that an individual would have to either being taking the CDL program concurrently or already have their CDL. She said, because Truck Drivers are a high growth occupation in our area we couldn't fund for additional training for an already Commercial Driving and we couldn't fund two programs if we were paying for the CDL. If an individual has skills that is employable, WIOA funds cannot be used to supplement another program. Gerald Waszkowiak motioned to not approve the request from Sauk Valley Community College's Commercial Drivers License-Truck Driving Entrepreneurship Program be added to the Eligible Training Provider List. Motion was seconded by Joel Torbeck. Roll call vote was taken.

#### **Other Business**

Carrie informed members that updates for the Opioid Grant, Apprenticeship Expansion Grant, IE Small Business Grant were listed on the Agenda and encouraged members to read the information. She also said that Partner Updates/Success Stories in included with the meeting materials for information purposes. Carrie said that as part of Service Integration everyone should be aware of all of the services and programs that each partner has available.

## Public Comments / Recognition of Guests

To keep in compliance with the Open Meetings Act, Carrie said that all members need to complete the online training provided by the Illinois Attorney General's office. She said that if a member needs to complete the training, Jo Ann will be getting information to you to complete the training.

Carrie informed members that Partners have been in Memorandum of Understanding (MOU) negotiation process. She said that Partners met on March 1 for a second budget meeting and another meeting is planned for March 22. As part of the process, Carrie said, a "Report of Outcomes" needs to be completed letting DCEO know the progress being made on the budget. That report is due on April 15. Carrie said that the document will need to be signed by both Cary Robbins and Linda Burt as Co-Chairs of NCI Works along with Jim Duffy (CEO Chair). Carrie commented that she just wanted all members to know the process. No action is needed until the budget is presented to NCI Works members at the May meeting.

Kris Noble asked Carrie to explain the budget for the system. Carrie explained that we have an independent negotiator that helps develop the budget. She said that all Partners have to agree on that budget and how the payments will be divided between the partners to support the system as a whole. As an example, Carrie said that Vanessa with Tri-County Opportunities Council has a staff person at the One Stop Center one day per week so they have a FTE (full-time equivalency) of .25. Carrie said that it's a 3-step process starting with the negotiations and ending with the reconciliation of invoices that Annette Pace does.

#### Adjournment

With there being no further business, Randy Freeman motioned to adjourn. Motion was seconded by Linda Hessenberger and carried. Meeting adjourned at 12:30 p.m.
