- Opioid Grant Update (See Report from Kerri Hicks below)

The Opioid Dislocated Worker Grant has had a total of 26 participants since starting in November 2019. The Grant received money again in September, I was able to enroll 2 more impacted Participants into a Paid Work Experience during this time. There have been 14 exited and 3 placed into Full-Time Employment.

In April when we transitioned 6 impacted Participants into WIOA services, we have 1 in an OJT and another still in the Grant enrolled in OJT as well. Another Client, who had been moved from OPI to WIOA has been placed into another Paid Work Experience at an Insurance Agency. We are currently having conversations with that worksite in regards to OJT. They are hoping to start in November.

### Little SUCCESS STORY about this Client:

My Client has worked hard for where she currently is. When enrolling her into the Opioid Grant, she was pregnant, had the baby and due to some unfortunate circumstances, had lost custody of her child to the State. During all of this, the Client stayed in constant contact with me, received treatment, has found housing, and is taking online courses to prepare for either Business Management or Accounting once all Pre-Req's have been completed. This Client's next goal is to be able to save enough money to be able to buy her own home that her and her children can all live in together. She does have 3 other little ones that she had lost custody prior to her enrolling into the Opioid Grant. This Client had taken many falls during our Program but throughout everything she overcame and continued to move forward and with the help of the Opioid Grant and our Services, we were able to help get her there.

Though it has been very quiet with referrals, those that are coming my direction, I am just reviewing all Pre-Applications with both Opioid Grant criteria and BEST qualifications. This has been discussed at our last Opioid Call with Tammy Stone – DCEO and all other LWIA's are reporting the same as far as a quiet time right now for referrals, we know they are out there but no one is completing applications for our Services at the moment. I am having conversations all the time with Agencies we have partnered with during this Grant – Arukah, Perfectly Flawed, and Sauk Valley Voices of Recovery just to make sure we are still present on everyone's mind.

## • Apprenticeship Expansion Grant Update (See report from Dianna Schuler below)

We have meet with a total of 168 individuals/companies either one on one or through our group events. We've held a total of 6 sector events. We the Hospitality/Tourism Sector event for October 15<sup>th</sup> and are working on an event for Apprenticeship Month in November.

Plastic Products, a manufacturer in Rock Island County, signed onto the Eastern Iowa Community College manufacturing standards recently. The program was already developed and meets the company's needs.

Nikelle is now working with Miller Excavating in Savanna on a custom set of standards for their employees. Nikelle is meeting with Miller, as she did with Plastic Products, on a weekly basis to get this program up and running.

We are very close to reaching our goals as set forth in our grant project plan. We now have 4 of the 5 new apprenticeships up and running with the 5<sup>th</sup> in the works. We also have 1 of the 3 expansions that we planned for completed. Because we have not been receiving any reimbursement requests from a few of our sub-contractors we are actually underspent in our grant at this point. We have taken measure (Annette actually has) to get the sub-contractors to

submit for reimbursement. We have also applied for an extension to March 31, 2022 to give us time to fully spend the grant.
