





October is National Disability Employment Awareness Month (NDEAM) and a busy month for our agency. In celebration, Division of Rehabilitation Services – DRS, Workforce Development Unit staff and counselors hosted a DRS Inaugural NDEAM Virtual Hiring Event. This event was created to support Division of Rehabilitation Services, Vocational Rehabilitation customers in the changing world of work during National Disability Employment Awareness Month (NDEAM) in October. The 3-day hiring event, October 19-21, 2021, included pre-employment workshops, employer presentations, as well as direct engagements in their respective breakout rooms.

The DRS Workforce Development Unit held an annual DRS Employer Recognition Award Celebration, which is always in October. This year's theme was **America's Recovery Powered by Inclusion**. The Workforce Development Unit recognized employers throughout the State and applauded them for their efforts in diversifying their workforce. Categories this year were the Employer of the Year Award, Employer Partnership Award, and the new Innovation Award category. On October 7th, DRS Business Services Consultants participated in the Sheridan Correctional Center Re-Entry Summit, and on October 29th, in the Statesville Correctional Center Re-Entry Summit. At the Re-Entry Summit's we met with 200+ inmates that were scheduled to be released within one week to 6 months, sharing information on DRS services and ways we can assist them when they're released with employment and educational services.

The Workforce Development Unit has also been working on a DRS Apprenticeship project, reaching out to employers and partners to obtain information on all 500+ Statewide Apprenticeship programs to learn and share "Earn & Learn" opportunities with customers and partners.
